WILL OF WILLIAM SOLLBERG

I, William Sollberg, of the City of Terre Haute, Indiana, do hereby make and declare this to be my last will and Testament, hereby revoking all former Wills by me made.

ITEM I.

It is my Will and I direct that, as soon as practicable after my death, all my just debts, including expenses of last sickness, burial and including reasonable cost of a monument or marker at my grave or a total cost not to exceed One Hundred Fifty Dollars (\$150.00), and the expenses of administration of my estate be first paid by my executor hereinafter named.

ITEM II.

Subject to the provisions of item I of this Will, I hereby give, devise and bequeath all the rest and residue of my property of every kind and character of which I may die the owner, real, personal, and mixed, whereever situated, to Henry K. Levin of the City of Terre Haute, Vigo County, Indiana, my Trustee, to have and to hold in fee simple absolute, but in trust for the following uses and purposes.

(1) Said trustee shall take possession of said trust estate and shall manage, improve, sell, convey, transfer, encumber and otherwise dealt with and handle said trust estate or any part thereof, in his absolute discretion, and invest and reinvest said trust estate and the funds therein or any part thereof in his absolute discretion, in any and every way in which any owner could do so, without the consent

in order of any Court and without posting bond, as full and completely as if he were the absolute owner thereof; said Trustee shall have the power, in his own name or Trustee, to collect all income, rents and profits of every kind and character arising from the property held by him in trust under the terms hereof; said Trustee shall have the power to pay all proper costs.

expenses and charges of every kind and character arising out of the administration of said trust, including his reasonable compensation, taxes and expenses of maintaining and preserving any and all of the property at any time held by him in trust under the terms hereof.

In the event said Harry N. Levin shall not be living at the time of my death, or shall die prior to the termination of the trust herein created, or if for any cause whatsoever he shall fail or refuse to qualify as Trustee under this Item of this Will, I hereby will, devise and bequeath the property hereinabove willed, devised and bequeathed to him as Trustee, to the Merchants National Bank of Terre Haute, as Trustee thereof for the term and with the powers and upon the uses and trust hereinabove set forth in said devise and bequest to said Harry N. Levin, as Trustee, and said Merchants National Bank of Terre Haute, as Trustee shall have the same powers, authorities and discretions hereinabove granted to said Harry N. Levin, as Trustee.

ITEM III

As soon as practicable after my death said Trustee shall sell all of the assets of said trust and convert the same into cash, and out of the proceeds of the sale of said assets of said trust, shall pay to each of the following named institutions

In the proceeds realized from the sale of said residence, if for any reason
insufficient to pay all said sums to said institutions, said proceeds shall be
paid so far as such proceeds may suffice, to the said institutions in the order
above named.

ITEM IV.

After payment of the several sums to the institutions mentioned in Item III
before, said trustee shall pay deliver and give all the sum and residue
of said trust fund to the trustees of Gen Eden Lodge No. 110 of Knights
Terre Haute, Indiana, and their successors to have and to hold as their own
in fee simple absolute and the receipt of said Trustees for said residue
shall terminate said trust. It is my desire that the trustees of Gen Eden

under my hand Britth, Terre Haute, Indiana, and their successors shall
be entitled to said gift as the William Wollberg Memorial Fund and to dispose of
said fund or the income thereof for Jewish victims of persecution in any
part of the world and not more than 10% of the principal during any one year
for the same purpose when there is need of such funds.

ITEM V.

I hereby name and appoint my friend, Harry N. Levin, of Terre Haute,
Indiana, as executor of this, my last will, and testament and in the event
he shall pre-decease me or shall die prior to the final settlement of my
estate or in the event he shall fail or refuse for any reason whatsoever
to qualify, or shall resign as executor of this, my last Will and Testament,
then and in either of such events, I hereby name and appoint said The
Merchants National Bank of Terre Haute, as executor of this, my last will
and testament in place and instead of said Harry N. Levin.



Levin R. Sutin before said Clerk, who being duly sworn on his oath, averred that he and Leon Levin were subscriber witnesses to said instrument of writing of date aforesaid and testified to the due execution thereof by said testator, as and for his last will and testament, and as to the competency of said testator to execute the same, and his freedom in such execution from any coercion or restraint, all of which testimony was by said Clerk thereupon reduced to writing and subscribed by said witness.

And it appearing to said Clerk from said testimony that said will was duly proven, and no objections to the probate thereof being shown, the same was by said Clerk, on the date aforesaid, admitted to probate and record, as the last will and testament of William Wellborn, deceased, late of Vigo County, Indiana, and as such is certified by the said Clerk, and duly entered of record in the Will Books of this court, together with the proof of will and certificate of probate thereof.

And the Clerk further avvemts to said court that Henry N. Levin is named in said will as Executor thereof, and the Clerk fixed bond in the sum of \$15,000.00. That on said date aforesaid, said Clerk issued Letters Testamentary on the will of said William Wellborn, deceased, to the said H. N. Levin. That on said date aforesaid, and prior to the issuance of said Letters, the said Henry N. Levin appeared before him before a Notary Public, and an affidavit was made and filed with said Clerk on the 2nd day of January, 1919, in the name of said decedent, to be administered upon, and the said Henry N. Levin took and subscribed an oath for the faithful discharge of the duties of said trust, and executed bond in the sum of \$15,000.00, duly conditioned as provided by law, with the Clerk and County Clerks and Register of Deeds, which bond before executed by the Clerk, the same was approved and acknowledged.
